- Tim Schwab and Joel Soden STA plan for park and ride
- Told to study 20 transit projects
- Moran Prairie park and ride one of seven connection facilities to be evaluated in study
- Park and Ride would be southern terminal for Five Mile to Moran Prairie High performance transit corridor
- Want to enhance pedestrian and bicycle access to corridor
- Studying eight sites near end of bus route along arterial or bus route for park and ride
- Looking at feasibility, no money to build
- Open house Oct. 29 6:30-8:30 p.m. at Moran Prairie Elementary
- Will discuss 8 sites, narrow to 3
- All sites outside city limits
- Site likely to be about one acre
- Want to provide place to park for riders

- Oct. 3 one day over 24-hour period 1,953 vehicles checked on 44th near Shopko average 21mph, 2.4 percent 36-41 mph, .3 percent 41-45mph, .1 percent 46-50 mph.
- 1,339 vehicles counted on 44th just east of Shopko. 25 mph mean speed
- 577 vehicles counted on Apollo north of 44th. mean speed 19 mph
